# NOAA Fisheries Seeks Comments on Amendment 4 to the Fishery Management Plan for Corals and Reef Associated Plants and Invertebrates of the U.S. Caribbean Region

Comment Period Ends April 26, 2013

NOAA Fisheries is seeking public comment on Amendment 4 to the Fishery Management Plan for Corals and Reef Associated Plants and Invertebrates of Puerto Rico and the U.S. Virgin Islands (Amendment 4). The amendment proposes to modify management of seagrasses in federal waters of the U.S. Caribbean.

The Caribbean Fishery Management Council (Council) has submitted Amendment 4 to NOAA Fisheries for review, approval, and implementation. The Notice of Availability for public comment on this amendment published in the *Federal Register* on February 25, 2013 (78 FR 12703).

The Council and NOAA Fisheries developed Amendment 4 to address the future management of seagrasses in federal waters of the U.S. Caribbean in accordance with the Magnuson-Stevens Fishery Conservation and Management Act. amendment would remove seagrass species from the fishery Management plan. The Council determined that federal management of these species is unnecessary because there is no known harvest of seagrass species, these species occur predominately in state waters of Puerto Rico and the U.S. Virgin Islands, and seagrasses are designated as essential fish habitat and habitat areas of particular concern in all of the Council fishery management plans.
