## **NOAA Fisheries Asks for Public Input in Preparation for Developing a Comprehensive Fishery Management Plan for Federal Waters of St. Thomas/St. John, United States Virgin Islands.**

*Moving from Species Based to Island Based Management*

*Comment Period for the Notice of Intent Ends July 8, 2013*

NOAA Fisheries, along with the Caribbean Fishery Management Council, intends to prepare a draft environmental impact statement to outline a range of management alternatives to be considered for a comprehensive management plan for the federal waters of St. Thomas/St. John.

The agency is hosting a series of scoping meetings to give people the opportunity to provide comments on the actions addressed in the environmental impact statement. Prior to these meetings the public can submit written comments on developing an island-based approach to fishery management from now through **July 8, 2013**.

This comprehensive plan will incorporate and modify, as needed, federal fisheries management measures included in each of the existing species-based management plans (Spiny Lobster, Reef Fish, Coral, and Queen Conch).

The goal is to create a management plan tailored to the specific fishery management needs of St. Thomas/St. John. If approved, this new management plan for St. Thomas/St. John in conjunction with similar plans being developed for St. Croix and Puerto Rico, will replace the current species-based plans presently governing commercial and recreational harvest in the U.S. Caribbean federal waters.
