



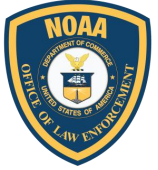

- vessels in Bajo de Sico with catch



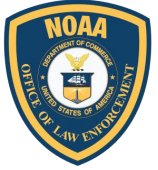
Seafood Mislabeling Complaints

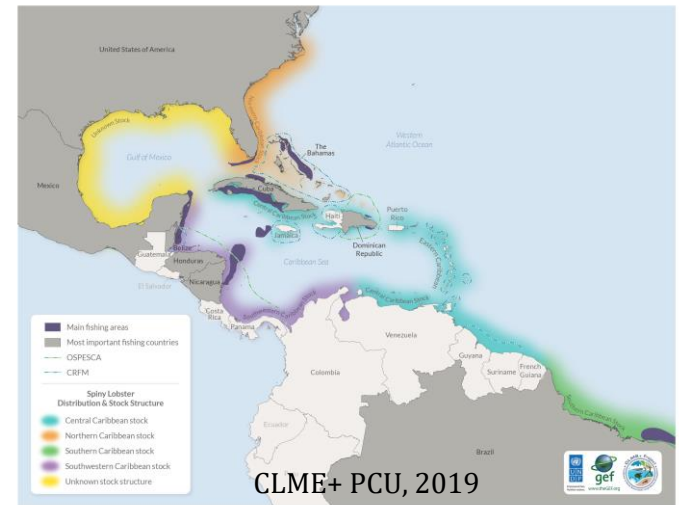

RECENT CASES

Aifa Seafood Inc

- 2019 shipments spiny lobster from FL to China (Haiti origin)
- Pled guilty, May sentencing

Elite Sky

- 2018-2019 spiny lobster from FL to China (Nicaragua/Belize origins)
- \$250,000 fine, 5 yrs probation

Operation Rock Bottom Defendant

- \$10,000 fine
- 5 yrs probation, community service
- Ban on snorkel/scuba within PR EEZ
- Ban on marine aquarium business, collecting/owning marine organisms
