
## **Revision of the Magnuson Stevens Act National Standard 1 Guidelines**

NS1 is a critical component to MSA success that requires U.S. fisheries management to prevent overfishing and achieve optimum yield (OY).

The NS1 Guidelines present revision is updated on how to achieve these requirements by providing tools to further improve upon federal fisheries management. One of the outstanding revision is the phasing-in of catch levels as shown in the diagram. This revision presents no changes to the Fisheries Management Plan (FMPs) in place.

### Accountability Measure Timing-Update on Status Following Secretarial Submission

1. Based on the results from different meetings with fishers on Accountability Measures (AMs) an amendment was submitted to the Secretary of Commerce so that if any AM based closures were needed in 2017, the closures would be starting on September 30, 2017, moving backward into the year for the number of days necessary to achieve the required reduction in landings. Thus, minimizing the socio-economic impact of AM closures, while still limiting catch levels to the applicable annual catch limits and preventing overfishing.

## Update on the development of a permit program for harvest of Snapper Unit 2 from the Puerto Rico EEZ

2. After extensive discussion of the outcomes from the Scoping Meetings held in Puerto Rico, on the development of a permit program for harvest of Snapper Unit 2 (queen and cardinal snappers) from the Puerto Rico EEZ, a Motion was presented, and approved, to table the decision on the permits until the appropriate time

when the Council gets the information –from Puerto Rico –needed for this permit not later than 2018.



## **Puerto Rico Fishers Spiny Lobster Data Collection Initiative**

3. For the past two years, spiny lobster fishers from Puerto Rico have been testing a new type of lobster traps in different areas and gathering information on the status of the spiny lobster, life history and landings. In the 158th CFMC Meeting fishers' representatives met with the scientists to discuss the nature and extent of the information needed by the scientists for a better assessment. The fishers decided to undertake an inventory of lobster fishers, type of gear and differences between the types of traps. This information will be submitted to the scientists to prepare a sample design adequate to this fishery. The final goal of this project is for fishers to provide the best data on spiny lobster populations useful to the scientists for their Annual Catch Limit (ACL) determination.

## **Island-based Fishery Management Plans**

On the status of the Island Based Fishery Management Plans (IBFMP), there was ample discussion on several issues. A list of Goals and Objectives from PR, St. Thomas/St. John and St. Croix were received by the Council. Other issues discussed include the request to the SSC to continue working on \*Acceptable Biological Catch (ABC) Control Rule and the alternatives for the IBFMPs. The SSC and the DAPs will meet early in 2017 to discuss the draft documents

\* Acceptable Biological Catch (ABC) Control Rule = acceptable biological catch (ABC), which is the catch level that accounts for scientific uncertainty in the estimate of the overfishing limit (OFL) and other sources of scientific uncertainty. The NS1 guidelines further require each Council, in conjunction with its SSC, to establish an ABC control rule that specifies how ABC is calculated based on the scientific uncertainty in the OFL estimate and the Council's risk policy.

## **Ongoing Reef Fish and Spiny Lobster Endangered Species 7 Consultation**

Jennifer Lee, from SERO/PRD, presented an update on Reef Fish and Spiny Lobster FMPs Endangered Species Consultation. SERO is updating the list of species which have been included in endangered species list since 2014. With this information, the Reef Fish and the Spiny lobster FMPs must be amended to include the new species. ## **Alternative Annual Catch Limit Benchmark**

On the issue of developing an alternative annual catch limit (ACL) benchmark for application of accountability measures (AMs), Bill Arnold presented the need for this action. The objective is to revise the way accountability measures are triggered and applied to minimize the risk of fishery closures of the Puerto Rico reef fish fishery and reduce negative socio-economic impacts. This will ensure to the greatest degree practicable that optimum yield is achieved for federally managed reef fish fisheries while preventing the fishery from exceeding the overfishing limit. A motion to develop amendment for the reef fish FMP to revise the trigger for applying AMs was presented and approved.
